**RESOLUTION NO. 15-1445-2021**

WHEREAS, the Local Housing Board passed the Board Resolution No. 2020-12-051 during its regular meeting on December 3, 2020, which resolution requested to grant a livelihood assistance of Five thousand pesos (P5,000.00) to 910 qualified beneficiaries;

WHEREAS, assistance is a central component of the Division for the Welfare of the Urban Poor (DWUP)-initiated livelihood project called the Micro Enterprise Development Fund, which aims to revive 1,000 community-based enterprises inside the city's socialized housing sites that have closed due to depleted capital as an offshoot of the COVID-19 pandemic;

WHEREAS, the qualified beneficiaries, 910 of them, are micro enterprise owners with community-relevant businesses inside Cebu City's socialized housing sites in the barangays of Apas, Basak Pardo, Basak San Nicolas, Binaliw, Budlaan, Bulacao, Busay, Calamba, Capitol Site, Duljo Fatima, Ermita, Hipodromo, Inayawan, Kalunasan, Kamputhaw, Kinasang-an, Labangon, Lahug, Lorega, Pahina Central, Poblacion Pardo, Sambag I, Pardo, Pit-os, Quiot, and Tisa;

WHEREAS, a system has been put in place that enables the Division for the Welfare of the Urban Poor (DWUP) to track the performance of the Micro Enterprise Development Fund project vis-à-

vis the set objectives, and to report and resolve issues and gaps in the implementation by monitoring and evaluating the beneficiaries quarterly;

WHEREAS, on December 9, 2020, the Office of the City Budget Officer certified the existence of an appropriation under account number 7999-50-2-99-990-77 (Livelihood Assistance Program) in the amount of Five million pesos (P5,000,000.00); and

WHEREAS, on December 16, 2020, the Office of the City Treasurer certified that funds are available to cover the livelihood assistance to 1,000 beneficiaries in the amount of Five million pesos (P5,000,000.00) under account code 7999-50-2-99-990-77 (Livelihood Assistance Program).

THEREFORE, the Sangguniang Panlungsod of the City of Cebu, as moved by Councilor Garcia and seconded by Councilor Zafra:

RESOLVED, to grant the livelihood assistance in the amount of Five thousand pesos (P5,000.00) each to the 910 qualified beneficiaries in accordance with the guidelines set in the approved livelihood project called the Micro Enterprise Development Fund, chargeable to account number 7999-50-2-99-990-77 (Livelihood Assistance Program), and for Division for the Welfare of the Urban Poor (DWUP) to monitor the same to ensure the achievement of the identified project goals and objectives; and

RESOLVED FURTHER, to authorize the Acting Secretary to the Sangguniang Panlungsod to furnish copies of this resolution to the Office of the Mayor, Office of the City Budget Officer, Office of the City Accountant, Office of the City Treasurer, Division for the Welfare of the Urban Poor (DWUP), Local Housing Board, all of this city, for their information and guidance.
